4 PILLARS

INTEGRATED SUPPORT SERVICES

Integrated student supports, which can support student success by meeting their academic, physical, social-emotional, and mental health needs. This means schools organize services like health check-ups, counseling, and support for tough times. It's important because when schools really understand students, they can help them better.

ACTIVE FAMILY AND COMMUNITY ENGAGEMENT

Family and community engagement, which involves actively tapping the expertise and knowledge of family and community members to serve as true partners in supporting and educating students. This includes things like visiting homes, home-school collaboration, and partnering with different community groups in a way that respects everyone's culture. It's about making sure families have chances to learn too, and that everyone can work together to make decisions and lead.

COLLABORATIVE LEADERSHIP AND PRACTICES FOR EDUCATORS

Collaborative leadership and practices for educators and administrators that establish a culture of professional learning, collective trust, and shared responsibility for outcomes in a manner that includes students, families, and community members. This includes training to improve how schools feel and how kids learn, focusing on mental health, emotions, and making things right when there's been a problem.

EXTENDED LEARNING TIME AND OPPORTUNITIES

Extended learning time and opportunities that include academic support, enrichment, and real-world learning opportunities, like internships, and project-based learning. This means opportunities as both "extended learning" and "expanded learning" and defines them as including "before and after school, winter programs, spring programs and summer programs.

Extended learning time and opportunities

Including before school, after school, intersessions and summer.

POTENTIAL FUNDING



Awards should not exceed \$500,000 per school and new, continuing, or expanding CS shall be funded for at least five years.

The grant requires a local match equal to one-third (33%) of the grant amount. The local match can be contributed in cash or as services/resources of comparable value.

INTENT OF THE GRANT

The intent of the CCSPP Implementation Grant is to act as seed money, fostering partnerships and creating a supportive community village to serve and uplift local communities.

Funding may be used for any of the following purposes

- Staffing, including, but not limited to, a community school coordinator.
- Coordinating and providing support services to pupils/families through childcare, expanded learning time before and after school, and during school intersessions.

Providing training/support to LEA personnel, and partner agency personnel on

- Integrating school-based pupil supports
- ✓ Social-emotional well-being
- ▼ Trauma-informed practices
- ☑ Establishing sustainable community
